Impact on Admissions Process

As such, an audition at the Norfolk Institute of Performing Arts is an opportunity for prospective students to consider whether the course would be a good fit for themselves, as well as an opportunity to identify potential.

Stage 1: Application

All candidates are required to submit an online application to audition, via the Institute's website. The application process is administered by the directors and applicant data is stored in line with our Data Protection policy.

Stage 2: Audition

Successful applications will be contacted with audition details. The audition will consist of performing arts classes taught by our faculty, followed by a prepared performance piece and interview.

We strive to offer auditions to as many candidates as possible; in the case of an unsuccessful application, candidates will be contacted, given feedback on why they were not invited to audition, and invited to reapply once they have worked to improve the areas indicated by our feedback.

The Institute admits pupils on the basis of ability or perceived potential ability in one or more of the vocational courses within the school. Suitability for a place at the school is determined on talent and potential shown at the time of audition. The decision of the audition panel is final and there is no opportunity for appeal

Stage 3: Decision

Auditionees are contacted within 24 hours of auditioning with the audition panel's decision. Successful candidates will be given further course details and invited to an induction day. We are also very happy to accommodate parent meetings, student meetings and site tours, as applicable, to enable a smooth transition.

Equal Opportunities
